Day 1 Fly to Phoenix / To Sedona (D) Arrive in Phoenix and meet your Tour Manager.

The spectacular four-hour ride in a First Class Railcar takes you between two national forests, past crimson cliffs, over old-fashioned trestles and through a 680-foot tunnel. Return to Sedona for another free evening.
